### **Footnotes**

- 1. **License**: The Free API comes with a CC-BY-NC 4.0 license, which allows for non-commercial use with attribution. The other tiers have commercial licenses with restrictions on use cases (internal, external, or reseller) and the number of products.
- 2. **Use Case**: Following definitions apply:
  - Internal Use: This use case covers any scenario where the API data is used exclusively within
    the organization for purposes such as internal analytics, decision-making, or carbon
    offsetting initiatives. The data is not shared externally or used in any customer-facing
    products or services.
  - 2. **Public Display**: This use case permits the API data to be included in publicly accessible products, services, or communications, such as on websites, apps, or reports. The data can be shared with customers or users to provide transparency, showcase environmental impact, or promote sustainability efforts.
  - 3. **Integration and Resale**: This use case allows for the integration of the API data into third-party products or services, where it may be combined with other data or offered as a value-added feature. In this scenario, the API data can be resold or used as part of a larger service offering, such as carbon accounting or sustainability consulting.
- 3. **Number of B2B/B2C customers**: This denotes the maximum number of B2B and B2C customers allowed for each tier. We determine whether the numbers for B2C or B2B are exceeded based on publicly available information, such as app downloads, website traffic, user reviews, and other relevant metrics. If numbers are exceeded, we contact you regarding an Enterprise plan.
- 4. **API Request Rate**: All tiers follow a "fair use" policy, meaning users can make a reasonable number of requests without overloading the API or adversely affecting others.
- 5. **Currencies**: This category lists the supported cryptocurrencies. We constantly add new currencies and tokens and this list is subject to change. The list contains Bitcoin, Ethereum, BNB, Cardano, Solana, DogeCoin, Polkadot, Polygon, Avalanche, TRON, Litecoin, Cosmos, Bitcoin Cash, Algorand, Tezos, Bitcoin SV, ZCash and Dash.
- 6. **PoW/PoS currencies**: This refers to the number of supported PoW and PoS cryptocurrencies within each tier. Users can switch the list of currencies they like to use once a month.
- 7. **Address-specific calculation**: This feature allows users to calculate sustainability metrics for specific addresses or wallets. Users can obtain address-specific emissions/electricity consumption by analyzing the blockchain data themselves and applying it to the API data.
- 8. **Request new currencies**: We are happy to consider new currency requests and will review them on a case-by-case basis. Addition of new currencies is subject to charge.



## Terms and Conditions (T&Cs)

The use of the CCRI-API is subject to the following Terms and Conditions (T&Cs). Please read these T&Cs carefully before using the CCRI-API. By using the CCRI-API, you agree to these T&Cs.

#### 1. License and Usage

- 1.1. The CCRI-API is offered under various licenses. The Free-Tier is provided under the Creative Commons License CC BY-NC 4.0, while other tiers have restrictions regarding the number of B2B and B2C customers and the number of products in which the API may be used. The use of the CCRI-API is subject to the license terms of the respective tier.
- 1.2. Access to the CCRI-API is only permitted for individuals who have reached the age of 18. The collection of personal data is required to open an account. CCRI reserves the right to refuse the opening of accounts or to limit or restrict the number of accounts that a person may open.
- 1.3. The use of the CCRI-API is only permitted for the use cases specified in the respective tiers and must only occur within the agreed usage limits. Each user is obliged to use the CCRI-API in accordance with applicable laws and regulations and in compliance with these T&Cs. CCRI reserves the right to block access to the CCRI-API without prior notice in case of violation of these T&Cs or applicable laws and regulations.

#### 2. Pricing and Payment Terms

- 2.1. CCRI offers various tiers for the use of the CCRI-API, which include different prices and services.
- 2.2. For the Starter, Business, and Enterprise tiers, a monthly fee is charged. The exact prices are listed in this sheet or on the CCRI website.
- 2.3. For the Enterprise tier, pricing is done individually and upon request.
- 2.4. The user is obligated to pay the agreed monthly fee on time and in full. CCRI reserves the right to block access to the CCRI-API without prior notice in case of delay or late payment.
- 2.5. The user is responsible for all fees, taxes, or other charges associated with the use of the CCRI-API.
- 2.6. CCRI reserves the right to change prices and services at any time. Changes will be published on the CCRI website and will take effect at the time of publication.



#### 3. Liability and Warranty

- 3.1. CCRI provides no warranty or guarantee for the accuracy, completeness, or timeliness of the data and information provided through the CCRI-API.
- 3.2. CCRI is not liable for damages resulting from the use of the CCRI-API unless these damages were caused intentionally or through gross negligence. In any case, CCRI's liability is limited to the actual damage incurred or a maximum amount equal to the sum of the fees paid by the user in the last 12 months.
- 3.3. CCRI is not liable for indirect, incidental, or consequential damages arising from the use of the CCRI-API, such as lost profits, business interruption, or data loss.
- 3.4. CCRI is not liable for damages caused by interruptions or failures of the CCRI-API unless these interruptions or failures were caused intentionally or through gross negligence.
- 3.5. The user is responsible for ensuring that any data or information obtained through the CCRI-API is used in compliance with all applicable laws, regulations, and intellectual property rights. The user shall indemnify and hold CCRI harmless from any claims, damages, or liabilities arising from the user's violation of these terms and conditions or any applicable laws and regulations related to the use of the CCRI-API data.

#### 4. Data Rights and Ownership

- 4.1. By using the CCRI-API, the user acknowledges and agrees that all data, information, and intellectual property rights related to the CCRI-API and its content remain the exclusive property of CCRI. The user is granted a non-exclusive, non-transferable, and revocable license to access and use the data provided through the CCRI-API solely in accordance with the terms and conditions of the selected tier and these terms and conditions.
- 4.2. The user shall not claim ownership, reverse-engineer, modify, reproduce, or create derivative works based on the CCRI-API data, except as expressly permitted by the license terms of the selected tier. The user shall also not sublicense, sell, or distribute the data provided through the CCRI-API to third parties without the prior written consent of CCRI.
- 4.3. CCRI retains the right to monitor the use of the CCRI-API and take appropriate action in case of any unauthorized use, infringement, or violation of these terms and conditions or applicable laws and regulations.

#### 5. Contract Duration and Termination

- 5.1. The Free-Tier has an indefinite term. The other tiers have a minimum contract term of one month.
- 5.2. The contract can be terminated by either party at any time with a notice period of one month to the end of the respective contract period.
- 5.3. CCRI reserves the right to terminate the contract at any time for important reasons without observing a notice period.
- 5.4. The Crypto Carbon Ratings Institute reserves the right to terminate the use of the API and access to the account without prior notice if the user violates these Terms and Conditions / ToS.



#### 6. Data Protection

- 6.1. CCRI commits to comply with applicable data protection laws and to process personal data only within the scope of the CCRI-API and the applicable laws and regulations.
- 6.2. CCRI collects, processes, and uses personal data only to the extent necessary for providing the CCRI-API services or if the user has expressly consented.
- 6.3. CCRI does not disclose personal data to third parties unless this is necessary for the fulfillment of the contract or the user has expressly consented.
- 6.4. The user has the right to request information about the data stored about them at any time and to have it corrected or deleted if necessary.
- 6.5. For further information on the handling of personal data, including the collection, processing, and use of such data, we refer to our detailed privacy policy, which is available on the CCRI website.
- 6.6. CCRI points out that when using the CCRI-API, personal data may be transferred to countries outside the European Economic Area (EEA).
